



**HATZ DIESEL OF AMERICA, INC.
WARRANTY POLICY SUMMARY
FOR ENGINES BUILT PRIOR TO JANUARY 2006**

- A. New 4-cycle air-cooled diesel engines with automatic low oil pressure shutoff devices for a period of twenty-four (24) or 2,000 operating hours, or twenty-eight (28) months after date of invoice from Hatz.
- B. New 4-cycle air-cooled diesel engines without automatic low oil pressure shutoff devices for period of twelve (12) months or 2,000 operating hours, or sixteen (16) months after date of invoice from Hatz.
- C. Parts warranty for a period of six (6) months after the date of delivery to the original retail purchaser. No labor compensation.
- D. EPA Certified Non-road Compression Ignition Engines have the following items covered for a period of five (5) years or 3,000 operating hours; fuel injection pump(s), injection nozzle(s), crankcase breather valve assembly, air cleaner housing, intake manifold, exhaust manifold, oil filler cap and exhaust gaskets at head interfaces.

FOR ENGINES BUILT PRIOR TO JANUARY 2006**



HATZ DIESEL OF AMERICA, INC., hereinafter referred to as "HATZ" warrants each new 4-cycle air-cooled diesel engine with automatic low oil pressure shutoff device and sold by Hatz to be free from defects in material and workmanship, under normal use and service, for a period of twenty-four (24) months or 2,000 operating hours after the date of delivery to the original retail purchaser, or twenty-eight (28) months after the date of invoice by Hatz, whichever occurs first, and Hatz will, at their option, repair or replace at Hatz's sales headquarters, or at a point designated by Hatz, any part or parts which shall appear to the satisfaction of Hatz upon inspection at such point, to have been defective in material or workmanship. This Warranty does not obligate Hatz to bear any transportation charges in connection with the repair or replacement of defective parts and such charges shall be borne by the original retail purchaser.

In order to obtain service under this Warranty, the original retail purchaser shall give notice in writing to Hatz within ten (10) days of the time that the defect becomes apparent. Repairs must be completed in a timely manner. Claims must be received at Hatz no later than thirty (30) days after repair date.

This Warranty shall not apply to any engine which shall have been installed or operated in a manner not recommended by Hatz; nor to any engine which shall have been repaired, altered, neglected or used in any way which, in the opinion of Hatz, adversely affects its performance; nor to any engine in which parts not authorized by Hatz have been used, which parts or the use of which have damaged, caused defects in, or otherwise adversely affected the engine or its performance; nor to any accessories installed on the engine where the accessory manufacturer has its own warranty; nor to normal maintenance services or replacement of normal service items.

Hatz reserves the right to modify, alter and improve any engine or parts without incurring any obligation to replace any engine or parts previously sold without such modified, altered or improved engine or parts.

Hatz reserves the right to require that any engine upon which warranty service is sought be made available to Hatz at Hatz's sales headquarters or point designated by Hatz free and clear of any liens and other encumbrances.

HATZ DIESEL OF AMERICA, INC., hereinafter referred to as "HATZ", warrants each new 4-cycle air-cooled diesel engine without automatic low oil shutoff device and sold by Hatz to be free from defects in material and workmanship, under normal use and service, for a period of twelve (12) months or 2,000 operating hours after the date of delivery to the original retail purchaser, or sixteen (16) months after the date of invoice by Hatz, whichever occurs first, and Hatz will, at their option, repair or replace at Hatz's sales headquarters, or at a point designated by Hatz, any part or parts which shall appear to the satisfaction of Hatz upon inspection at such point, to have been defective in material or workmanship. This Warranty does not obligate Hatz to bear any transportation charges in connection with the repair or replacement of defective parts and such charges shall be borne by the original retail purchaser.

In order to obtain service under this Warranty, the original retail purchaser shall give notice in writing to Hatz within ten (10) days of the time that the defect becomes apparent. Repairs must be completed in a timely manner. Claims must be received at Hatz no later than thirty (30) days after repair date.

Hatz reserves the right to require that any engine upon which warranty service is sought be made available to Hatz at Hatz's sales headquarters or point designated by Hatz free and clear of any liens and other encumbrances.

HATZ DIESEL LIMITED PARTS WARRANTY

HATZ DIESEL OF AMERICA, INC., hereinafter referred to as "HATZ", warrants each new spare part sold by Hatz to be free from defects in material and workmanship, under normal use and service, for a period of six (6) months after the date of delivery to the original retail purchaser, and Hatz will, at their option, repair or replace at Hatz's sales headquarters, or at a point designated by Hatz, any part or parts which shall appear to the satisfaction of Hatz upon inspection at such point, to have been defective in material or workmanship. This Warranty does not obligate Hatz to bear any labor or transportation charges in connection with the repair or replacement of defective parts and such charges shall be borne by the original retail purchaser.

In order to obtain service under this Warranty, the original retail purchaser shall give notice in writing to Hatz within ten (10) days of the time the defect becomes apparent. Claims must be received at Hatz no later than thirty (30) days after part defect date.

This Warranty shall not apply to any parts which shall have been installed or used in a manner not recommended by Hatz; nor to any part which shall have been repaired, altered, neglected or used in any way which, in the opinion of Hatz, adversely affects its performance; nor to any part which is not a genuine Hatz part, the use of which will damage, cause defects in, or otherwise adversely affect the engine or its performance; nor to any accessories installed where the accessory manufactured has its own warranty; nor to normal maintenance services or replacement of normal service items.

Hatz reserves the right to require that any part upon which warranty service is sought be made available to Hatz at Hatz's sales headquarters or point designated by Hatz free and clear of any liens and other encumbrances.

THIS LIMITED PARTS WARRANTY, AND THE OBLIGATION OF HATZ HEREUNDER, ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE, and all other obligations or liabilities, including actual, special, direct, indirect, incidental or consequential damages, lost profits, lost sales, lost time, lost use, or contingent liabilities arising out of the failure of any part to operate properly. No person is authorized to give any other warranty or to assume any additional obligation on behalf of Hatz unless made in writing and signed by an officer of Hatz.

WARRANTY EXCLUSIONS

The following items will not be covered in the second year (13-24 months) under the Premier Engine Warranty:

- ◆ Electrical components ◆ Hoses ◆ Belts ◆ Sealants
- ◆ Sealing compounds ◆ Adhesives ◆ Gaskets ◆ Clutches
- ◆ Hydraulic components ◆ Injection nozzles ◆ Gear Cases
- ◆ Incidental expenses: travel time, mileage, and freight
- ◆ Components functionally dependent on the oil circuit on engines without low oil pressure shutoff devices

ITEMS NOT COVERED BY WARRANTY

- ◆ Lubricants, fuels, shop towels, supplies and hazardous waste disposal
- ◆ Phone/Fax/Communication costs
- ◆ Deterioration caused by poor or prolonged storage of an engine such as rust, corrosion or gum and varnish caused by deteriorating fuel
- ◆ Any sales taxes
- ◆ Diagnostic and/or cleaning time
- ◆ Overtime labor
- ◆ Damage caused by the use of any starting aid or fluid
